CANCELLATION If you must cancel your trip, your deposit and all payments will be refunded, less a cancellation fee. If written notice of cancellation is received in our office more than 60 days prior to departure, the fee is \$250. 59-29 days- 25% of the total tour cost, between 28 – 16 days before departure, the fee is 75% of the total tour cost, between 15 to 1 day before departure the fee is 85% of the total tour cost. No refunds for no shows. **Trip cancellation & interruption insurance is recommended** and available at modest rates.
